88 **Construction Agreement (to be distributed)**

90 Ms. Comings-Thibault presented Consideration and Approval of the Partial Assignment of
91 Sawgrass Bay Boulevard Construction Agreement and asked for comments or questions.

92 Ms. Wilson commented that this was a partial assignment of the agreement for the drainage and
93 roadway components only. She also said the maximum payment the District's obligated to make under
94 this assignment is \$2.5 million. Ms. Smith commented it is for \$2.3 million. Ms. Wilson stated that she
95 would modify if necessary and also that they were asking the Board approve this assignment in form,
96 subject to the change and subject to the approval of the Developer and the Contractor.

97 On a MOTION by Mr. Harvey, SECONDED by Mr. Meath, WITH ALL IN FAVOR, the Board
98 approved the Partial Assignment of Sawgrass Bay Boulevard Construction Agreement for the Avalon
99 Groves Community Development District.

101 **FIFTH ORDER OF BUSINESS – Staff Reports**

106 Mr. Harvey commented that this appraisal was ordered by the District in order to establish the
107 value for some parcels that the District was going to be acquiring. The appraisal addressed the value of
108 wetland acres and upland acres, and the Developer has agreed to sell the District land at the lower of the
109 appraised value or cost value. It was determined that the value of \$3,000 per acre for wetlands was
110 appropriate, and although the appraisal shows a higher value per upland acre, we are actually using a
111 lower value for the uplands to tie back to the Developer's costs.

112 On a MOTION by Mr. Harvey, SECONDED by Mr. Meath, WITH ALL IN FAVOR, the Board
113 approved the Appraisal – 985 +/- Gross Acres Located East of the Existing Sawgrass Bay Boulevard in
114 Unincorporated Lake County for the Avalon Groves Community Development District.

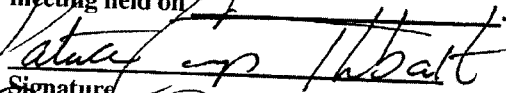
122 Mr. Harvey commented that the closing for the 2017 bonds was scheduled for next Wednesday in

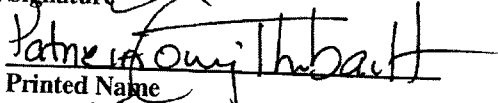
125 On a MOTION by Mr. Meath, SECONDED by Ms. Smith, WITH ALL IN FAVOR, the Board adjourned

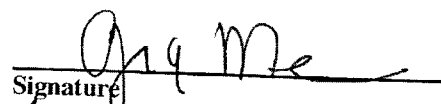

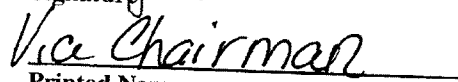
